RESOLUTION NO. SP. 2917 S-2005

A RESOLUTION DECLARING THE SHOW FEATURING KEVYN, LOU PARDINI AND JOE PIZZULO TO BE SPONSORED BY VENICE BEACH INDUSTRIES ON MAY 14, 2005 AT THE ARANETA COLISEUM, QUEZON CITY, FALLING WITHIN THE ALLOWABLE EXEMPTIONS EMBODIED IN SECTION 40, ARTICLE 15 OF THE QUEZON CITY REVENUE CODE.

WHEREAS, Section 192 of the Local Government Code provides that "Local government units may, through ordinances duly approved, grant tax exemptions, incentives or reliefs under such terms and conditions as they may deem necessary";

WHEREAS, the term "as they may deem necessary" is limited by a specific provision of the law allowing grants of tax exemption which is the Quezon City Revenue Code of 1993;

WHEREAS, Section 40 of the Quezon City Revenue Code provides that:

"The holding of operas, concerts, dramas, recitals, paintings and art exhibitions, flower shows, musical programs, literary and oratorical representations, except pop, rock or similar concerts shall be exempt from payment of the tax herein imposed"
