A RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT ENTERED BY AND BETWEEN THE QUEZON CITY GOVERNMENT, REPRESENTED BY THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., AND THE DEPARTMENT OF LABOR AND EMPLOYMENT – NATIONAL CAPITAL REGION (DOLE-NCR) REPRESENTED BY THEIR REGIONAL DIRECTOR MR. RICARDO S. MARTINEZ, SR. FOR THE PROGRAM “CAPACITY DEVELOPMENT OF LOCAL INSTITUTIONS TO PROMOTE AND PROTECT THE INFORMAL SECTOR (CLIPPS)”.

WHEREAS, the Department of Labor and Employment (DOLE) has a United Nations Development Program (UNDP) – sponsored program “Capacity Development of Local Institutions to Promote and Protect the Informal Sector (CLIPPS) which aim to enhance partnership between local government units (LGU’s) and their respective Informal Sector (IS) groups that are able to work together in identifying, organizing and developing joint programs and policies for the informal sector;

WHEREAS, the Quezon City government through the Industrial Relations Office/Public Employment Service Office (IRO/PESO), has actively supported the Department’s programs and has been selected by the DOLE-NCR as its recipient and partner in the implementation of the CLIPPS;




