A RESOLUTION GRANTING FINANCIAL ASSISTANCE IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00) TO THE BEREAVED FAMILY OF THE LATE LAUREANO S. RAMOS, FORMER PUNONG BARANGAY, BARANGAY BAGONG SILANGAN, QUEZON CITY, WHO DIED ON APRIL 29, 1997, CHARGEABLE AGAINST THE APPROPRIATIONS FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2005 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.


