A RESOLUTION GRANTING FINANCIAL ASSISTANCE IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00) TO THE BEREAVED FAMILY OF THE LATE LOPEZ LUDOVICA, SR., BARANGAY KAGAWAD, BARANGAY BATASAN HILLS, QUEZON CITY, WHO DIED ON JANUARY 17, 2002, CHARGEABLE AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUND OF THE CITY TREASURY.




NOW, THEREFORE,
