RESOLUTION NO. SP- 2935, S-2005

A RESOLUTION REQUESTING THE HONORABLE, MAYOR FELICIANO R. BELMONTE, JR., TO APPROVE AND FUND THE PURCHASE OF A VACANT PROPERTY AND CONSTRUCTION OF A COVERED BASKETBALL COURT AT MARINDUQUE STREET, BARANGAY DEL MONTE, QUEZON CITY.

Introduced by Councilors BERNADETTE HERRERA-DY, ELIZABETH A. DELARMENTE, VICTOR V. FERRER, JR., FRANCISCO A. CALALAY, JR., ROMMEL R. ABESAMIS, JOSEPH P. JUICO, ERIC Z. MEDINA and RESTITUTO B. MALAÑGEN.

WHEREAS, the Sport Development Program of Barangay Del Monte, Quezon City is a priority program aimed at developing the physical, mental and emotional well being of the youth in the community;

WHEREAS, such a priority program will keep the youth from engaging in activities and acts contrary to their personal well being, such as gambling and drug addiction;

WHEREAS, to implement this Sports Development Program, a venue for the sports and recreational activities must be made easily available and accessible to the youth and there is no such available venue in the said barangay;

WHEREAS, there is a vacant property along Marinduque Street, Barangay Del Monte, Quezon City that can possibly be converted into such venue;

WHEREAS, the purchase of said property and construction of a covered basketball court for that purpose could not be accommodated with the tight budget that the barangay is now experiencing.


