RESOLUTION NO. SP- **2938** <sup>th</sup>, S-2005

A RESOLUTION URGING THE NATIONAL POWER CORPORATION TO GRANT A ROAD RIGHT-OF-WAY TO F. CARLOS-MENDEZ-PAJO HOMEOWNERS ASSOCIATION REPRESENTED BY ITS PRESIDENT, MR. EFREN REYES FOR THE PROPOSED CMP PROJECT LOCATED AT BARANGAY APOLONIO SAMSON AND BAESA, QUEZON CITY.

Introduced by Councilors WINSTON "Winnie" T. CASTELO, RAMON P. MEDALLA, BERNADETTE HERRERA-DY, FRANCISCO A. CALALAY, JR., JORGE B. BANAL, JR., ANTONIO E. INTON, JR. and RESTITUTO B. MALAÑGEN.

WHEREAS, F. Carlos-Mendez-Pajo Homeowners Association represented by its President, Mr. Efren Reyes has recently signed a Memorandum of Agreement with the owner of a parcel of land for acquisition by the homeowners (informal) of the land they presently occupy for purposes of a socialized housing project;

WHEREAS, the land being acquired is adjacent to the National Power Corporation;

WHEREAS, one of the requirements for the approval of a Community Mortgage Program is the presence of a road right-of-way;

WHEREAS, the proposed road right-of-way is the property of the National Power Corporation;

WHEREAS, the Homeowners Association is now seeking the assistance of the City government thru a Council Resolution to urge the National Power Corporation for a grant of permanent road right-of-way for access to their proposed subdivision project to at least assure them of the safety and humane community living.
