A RESOLUTION URGING THE CITY ENGINEERING OFFICE TO CONDUCT A FEASIBILITY STUDY OF CONSTRUCTING A PEDESTRIAN OVERPASS/FOOTBRIDGE CROSSING BATASAN ROAD AT THE VICINITY OF BATASAN HIGH SCHOOL, QUEZON CITY.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge, the City Engineering Office to conduct a feasibility study of constructing a pedestrian overpass/footbridge crossing Batasan Road at the vicinity of Batasan High School, Quezon City.
