A RESOLUTION URGING THE HONORABLE, CITY MAYOR FELICIANO R. BELMONTE, JR. TO ALLOW THE DISPOSITION OF THE PARCEL OF LAND SITUATED AT ESPERANZA STREET, HILLTOP SUBDIVISION, BARANGAY GREATER LAGRO, QUEZON CITY, TO BE AWARDED TO THE ACTUAL AND QUALIFIED OCCUPANTS, IN ACCORDANCE WITH AND IN THE MANNER PRESCRIBED BY EXISTING LAWS.
