RESOLUTION NO. SP- 2952 S-2005

A RESOLUTION URGING THE HONORABLE, CITY MAYOR FELICIANO R. BELMONTE, JR., QUEZON CITY, FOR THE CONVERSION INTO A RESIDENTIAL AREA, THE PARCEL OF LAND OWNED BY THE QUEZON CITY GOVERNMENT DESCRIBED AS LOT 9, BLOCK 5, CONSISTING OF TWO THOUSAND FOUR HUNDRED SIXTY-TWO SQUARE METERS (2,462 SQ. M.), COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED 56495 (TOFEMI SUBDIVISION NO. 1), BARANGAY CULIAT, QUEZON CITY AND REQUESTING FOR ITS DISPOSITION TO THE ACTUAL AND BONAFIDE OCCUPANTS THEREOF.

WHEREAS, there is a parcel of land covered by Transfer Certificate of Title Numbered 56495, which is an open space owned by the Quezon City government, located at Tofemi Subdivision No. 1, Purok Sampaguita, Union Extension, Barangay Culiat, Quezon City;

WHEREAS, the afore-mentioned land have been occupied openly and continuously for many years by almost sixty-eight (68) informal settler families who have organized themselves into an association called Unionside Neighborhood Association;

WHEREAS, Barangay Culiat Council under its Resolution No. 011, S-2004, has requested the Urban Poor Affairs Office to convert the open space into a residential area and recommend to award the said land to its actual occupants.
