RESOLUTION NO. SP-2953 3-2005

A RESOLUTION URGING HIS HONOR, CITY MAYOR FELICIANO R. BELMONTE, JR. TO CAUSE THE RE-PUBLICATION OF THE QUEZON CITY REVENUE CODE EMBODYING THE AMENDMENTS APPROVED BY SUBSEQUENT ORDINANCES ENACTED BY THE CITY COUNCIL.

Introduced by Councilors BERNADETTE HERRERA-DY, ELIZABETH A. DELARMENTE, FRANCISCO A. CALALAY, JR., WINSTON "Winnie" T. CASTELO, RAMON P. MEDALLA, JORGE B. BANAL, JR., ANTONIO E. INTON, JR. and RESTITUTO B. MALAÑGEN.

WHEREAS, the Quezon City Council enacted Ordinance No. SP-91, S-93 entitled the Quezon City Revenue Code of 1993;

WHEREAS, the City government, in accordance with its mandate to afford its constituents access to information regarding matters of public concern, published the said Ordinance in booklet form, for distribution to public as ready reference material;

WHEREAS, the City Council has enacted several Ordinances amending the basic Revenue Ordinance since the release of the first publication in booklet form more or less ten (10) years ago;

WHEREAS, there is a need to cause the re-publication of the Quezon City Revenue Ordinance, as amended, in the most appropriate reference material format, in order to avoid misinformation and afford taxpayers full comprehensive and accurate information on matters related to local taxation;

WHEREAS, the re-publication of the Quezon City Revenue Code shall be taken from the budget of the City Treasurer's Office.
