RESOLUTION NO. SP- **2965** , S-2005

A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, QUEZON CITY, TO NEGOTIATE WITH THE OWNER OF, AND ACQUIRE BY WAY OF DIRECT PURCHASE, LOT NO. 168, FLS-2592-D, LOT NO. 160, BLK/FLS-2592-B, AND LOT NO. 167, BLK/FLS-2592-D COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED 77752 OF THE REGISTRY OF DEEDS OF QUEZON CITY, TO BE USED AS A SITE FOR THE ESTABLISHMENT/CONSTRUCTION OF NOVALICHES HIGH SCHOOL GULOD-ANNEX IN BARANGAY GULOD, NOVALICHES, QUEZON CITY.

WHEREAS, Quezon City Ordinance No. SP-1460, S-94 had been approved by His Honor, Mayor Feliciano R. Belmonte, Jr., for the establishment of Novaliches High School Gulod-Annex in Barangay Gulod, Novaliches, Quezon City,

WHEREAS, to ensure the realization of the said high school, the amount of Five Million Six Hundred Eighty-Eight Thousand Pesos (P5,688,000.00) had been allocated by the City Council through Resolution No. SP-2408, S-2004;

WHEREAS, in her Indorsement dated January 26, 2005, Dr. Victoria Q. Fuentes, Schools Division Superintendent, interposed no objection to the proposed high school;

WHEREAS, Architect Gerardo G. Magat, City Planning and Development Officer, likewise recommended the acquisition of the subject lots for the benefit of poor students, not only in Barangay Gulod, but of the entire Novaliches;



Belmonte, Jr., City Mayor, Quezon City, to negotiate with the owner of, and acquire by way of direct purchase, Lot No. 168, Fls-2592-D, Lot No. 160, Flk/Fls-2592-B, and Lot No. 167, Flk/Fls-2592-D covered by Transfer Certificate of Title Numbered 77752 of the Registry of Deeds of Quezon City, to be used as a site for the establishment/construction of Novaliches High School Gulod-Annex in Barangay Gulod, Novaliches, Quezon City.
