A RESOLUTION AUTHORIZING THE GRANT OF FINANCIAL ASSISTANCE IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) TO SPO4 RAMON L. JARAPA, WHO SERVED IN THE POLICE DEPARTMENT OF QUEZON CITY AND WAS A RECIPIENT OF OUTSTADING POLICEMAN OF QUEZON CITY IN 1980, 1981, AND 1984 AND OTHER AWARD OF MERITS FOR MERITORIOUS SERVICES.
