A RESOLUTION URGING THE NATIONAL POWER CORPORATION TO IMPLEMENT THE "ON-SITE DEVELOPMENT PROGRAM" THROUGH THE COMMUNITY MORTGAGE PROGRAM (CMP) IN THE DISPOSITION OF THEIR PROPERTY LOCATED AT SITIO SAN ROQUE, BARANGAY SANGANDAAN, QUEZON CITY, TO THE ACTUAL AND QUALIFIED OCCUPANTS/BENEFICIARIES.

WHEREAS, the actual occupants are now soliciting the assistance of the City government and the Honorable August Body to urge and convince the National Power Corporation (NPC) to implement the "on-site development program" in the disposition of the NPC land as an initial step in their quest for a decent shelter.
