
A RESOLUTION STRONGLY URGING THE HONORABLE, CITY MAYOR FELICIANO R. BELMONTE, JR., TO ALLOCATE THE NECESSARY FUNDS FOR THE PROCUREMENT OF AMBULANCES, FOR THE OFFICIAL USE OF HEALTH CENTER/S PER BARANGAY IN QUEZON CITY, TO BE TAKEN FROM ANY AVAILABLE FUND IN THE CITY TREASURY.

WHEREAS, public Health Centers are primarily tasked to deliver health care services to the constituents especially the less fortunate residents of Quezon City;

WHEREAS, numerous emergency patients had been brought to these health centers but their treatment are not within their capability due to the inadequacy or lack of medical equipments in said centers;

WHEREAS, the experiences of several health centers, particularly in District II, Quezon City, prompted them to earnestly request the procurement of ambulances in order to enhance their mobility as well as for use in emergency cases of transporting patients to the nearest hospital whenever their use arise.
