RESOLUTION NO. SP. 2975 S-2005

A RESOLUTION URGING THE LANDBANK OF THE PHILIPPINES, THRU THE QUEZON CITY GOVERNMENT REPRESENTED BY THE HONORABLE, CITY MAYOR FELICIANO R. BELMONTE, JR., TO CONSIDER THE POSSIBILITY OF DISPOSING THE RAMAWIL PROPERTY LOCATED IN PAYATAS, QUEZON CITY IN FAVOR OF THEIR QUALIFIED RESIDENTS/OCCUPANTS THRU THE COMMUNITY MORTGAGE PROGRAM OR THROUGH DIRECT PAYMENT IN ACCORDANCE WITH THE MANNER PRESCRIBED BY EXISTING LAWS.

WHEREAS, the percel of land described as Lot No. 69-B, PSD-760, containing an area of 9.6 hectares located at Barangay Payatas, Quezon City, was formerly owned by RAMAWIL before the same was foreclosed by Land Bank of the Philippines and as Trustee of the Quezon City government under a Deed of Revocable Trust;

WHEREAS, it has been tenanted and occupied by Two Hundred Fifty-Four (254) families for the last thirty (30) years;

WHEREAS, the residents of the RAMAWIL Property is now petitioning the City government to allow them to acquire the property thru the Community Mortgage Program or thru direct sale the lot they are actually occupying.

Belmonte, Jr., to consider the possibility of disposing the Ramawil Property located in Payatas, Quezon City in favor of their qualified residents/occupants thru the Community Mortgage Program or through direct payment in accordance with the manner prescribed by existing laws.
