RESOLUTION NO. SP-2976, S-2005

A RESOLUTION STRONGLY URGING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO INITIATE THE CONSTRUCTION OF A PEDESTRIAN OVERPASS/FOOTBRIDGE AT THE VICINITY OF BATASAN ELEMENTARY SCHOOL, CROSSING CONSTITUTIONAL ROAD, QUEZON CITY, THE FUNDS TO BE TAKEN FROM THE INFRASTRUCTURE FUND OR ANY AVAILABLE FUND IN THE CITY TREASURY.

WHEREAS, thousands of Elementary School children cross Constitutional Road in going-in-and-out of Batasan Elementary School during school days;

WHEREAS, the absence of a pedestrian overpass/footbridge that leads to Batasan Elementary School, posed a great threat/danger to loss of lives and limbs of the school children, their parents, teachers and residents in the vicinity;

WHEREAS, it had been observed by parents during the past school year, that the school children crossing Constitutional Road in going-in-and-out of the Batasan Elementary School had caused heavy traffic in the area;
