RESOLUTION NO. SP- 2977 S-2005

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO ATTY. ELIZABETH BALQUIN REYES, FORMER ASSISTANT CITY PROSECUTOR, QUEZON CITY FOR HER MORE THAN NINETEEN (19) YEARS OF SERVICE IN THE AMOUNT OF ONE HUNDRED FIFTY THOUSAND PESOS (P150,000.00) SUCH AMOUNT TO BE TAKEN FROM THE APPROPRIATIONS OF THE OFFICE OF THE CITY MAYOR UNDER GRANTS, SUBSIDIES AND CONTRIBUTIONS IN THE CITY'S ANNUAL BUDGET FOR FISCAL YEAR 2005.

WHEREAS, Prosecutor Elizabeth Balquin-Reyes, has rendered a total of more than nineteen (19) years of continuous, dedicated, efficient and competent service as a member of the Prosecution;

WHEREAS, prior to her appointment as Prosecutor of Quezon City, she was a member of the Western Police District (WPD) Manila's Finest for more than twelve (12) years;

WHEREAS, prior to her appointment as Prosecutor of Quezon City, she was given the award of merit as an Outstanding Police Woman of the Year on August 8, 1980, and awarded as the 1993 Most Outstanding Prosecutor of Quezon City by the Rotary Club of Downtown Cubao, given on the 3<sup>rd</sup> day of June 1994;
