RESOLUTION NO. SP- 2979, S-2005

A RESOLUTION ALLOCATING THE AMOUNT OF SIX MILLION EIGHT HUNDRED THIRTY-ONE THOUSAND THREE HUNDRED TWO PESOS AND TWENTY CENTAVOS (P6,831,302.20) FOR THE COSTS OF PRINTING AND DELIVERY OF DIVISION TEST MATERIALS FOR THE 2005 DIVISION ACHIEVEMENT TESTS FOR ELEMENTARY AND HIGH SCHOOL STUDENTS OF QUEZON CITY.

WHEREAS, the results of the National Achievement Tests throughout the country administered by the National Education Testing and Research Center to Grade Five pupils and Fourth Year High School students revealed that the pupils and students failed to master the learning competencies in English, Science and Mathematics;

WHEREAS, the Division of City Schools intends to administer a year end achievement test for the School Year 2004-2005 in the different learning areas primarily in English, Science, Math and Filipino to all pupils and students in the different grade and year levels;

WHEREAS, the objectives of this achievement tests are:

1. To identify the unmastered learning competencies of pupils in the four (4) learning areas namely: English, Science, Math and Filipino;
2. To institute appropriate intervention/remedial strategies for the mastery of said learning competencies; and
3. To establish baseline data for performance in the delivery of effective instructions.


WHEREAS, the Division of City Schools has estimated that the testing project for elementary pupils will cost P4,632,014.40 and P1,199,297.80 for high school students.

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to allocate, as it does hereby allocate, the amount of Six Million Eight Hundred Thirty-One Thousand Three Hundred Two Pesos and Twenty Centavos (P6,831,302.20) from any available funds of the City Treasury for the costs of printing and delivery of division test materials of 2005 Division Achievement Test for elementary and high school students of Quezon City broken down as follows:

1. Four Million Six Hundred Thirty-Two Thousand Fourteen Pesos and Forty Centavos (P4,632,014.40) for elementary students;
2. One Million One Hundred Ninety-Nine Thousand Two Hundred Ninety-Seven and Eighty Centavos (P1, 199,297.80) for high school students.
