A RESOLUTION AUTHORIZING THE HONORABLE, CITY MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH LAMAR INTEGRATED CONSTRUCTION CORPORATION FOR THE DEVELOPMENT AND CONSTRUCTION OF INTEGRATED SOLID WASTE DISPOSAL MANAGEMENT FACILITY OUTSIDE QUEZON CITY IN ACCORDANCE WITH REPUBLIC ACT 9003.

WHEREAS, Waste Disposal and Management is the prevailing problem in Metro Local Government Units including Quezon City;

WHEREAS, the Payatas dumping site which is for the exclusive use of Quezon City, has reached its peak and will be phased out in the next few years;

WHEREAS, the Quezon City government needs a long term, if not permanent, solution to its increasing waste disposal and waste management problem, that will come about after the Payatas Dumping Site be permanently closed;

WHEREAS, LAMAR Integrated Construction Corporation a duly organized and existing corporation equipped with modern technology as well as expert personnel is offering an Integrated Solid Waste Disposal and Management to the City government;

WHEREAS, pursuant to Section 455 (vi) of the Local Government Code, the City Mayor could represent the City government to enter into contracts upon authority of the Sangguniang Panlungsod.
