RESOLUTION DECLARING BARANGAY SOUTH TRIANGLE AS THE "HEART OF QUEZON CITY" BY VIRTUE OF ITS STRATEGIC LOCATION BEING THE CENTER OF BOTH COMMERCIAL AND ENTERTAINMENT ESTABLISHMENTS AND HOME TO GIANT BROADCAST NETWORKS, MOVIE PRODUCTIONS OUTFITS, FINE DINING RESTAURANTS AND BARS AND SHOPPING ARCADES.
