RESOLUTION AMENDING RESOLUTION NO. SP-2628, S-2004, IN ORDER TO CHANGE THE LOCATION OF THE BUS TERMINAL STATION OF THE PHILTRANCO SERVICE ENTERPRISES, INCORPORATED FROM 5<sup>TH</sup> AVENUE CORNER P. TUAZON BOULEVARD, BARANGAY SOCORRO TO EDSA NEAR BANAHAW STREET, QUEZON CITY.

WHEREAS, on October 26, 2004, the City Council adopted a Resolution No. SP-2628, S-2004, entitled "Resolution authorizing the issuance of a Special Use Permit to Philtranco Service Enterprises, Inc., (PSEI) for the construction and operation of a bus terminal station located along 5<sup>th</sup> Avenue, cor. P. Tuazon Blvd., Bgy. Socorro, Quezon City;

WHEREAS, Philtranco have found the location of the bus station terminal along 5<sup>th</sup> Ave., cor., P. Tuazon Blvd., Socorro, Quezon City, as not feasible for a bus terminal and in lieu thereof, have considered another site located along EDSA near Banahaw St., Quezon City;

WHEREAS, the said new site, the locational map thereof is hereto attached and made an integral part of this resolution was duly indorsed by the Metro Manila Development Authority, as the use thereof "will not hamper the flow of vehicles at EDSA."
