A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO P/INSP. ILLUMINADO MANUEL RAMOS OF THE CENTRAL POLICE DISTRICT COMMAND, WHO DIED ON 08 FEBRUARY 2005, IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) AND APPROPRIATING THE AMOUNT NEEDED THEREFORE, TO BE TAKEN FROM THE SOCIAL FUND OF THE CITY MAYOR OR FROM ANY AVAILABLE FUND OF THE CITY.

WHEREAS, as token and gesture to the contribution of P/Insp. Iuminado Manuel Ramos in maintaining peace and order and loyalty to the service during his incumbency it is justifiable for the City government to grant financial assistance to said P/Insp. Ramos who died on February 8, 2005.


