A RESOLUTION GRANTING FINANCIAL ASSISTANCE IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) TO THE BEREAVED FAMILY OF THE LATE LORENZO C. BAETIONG, FORMER BARANGAY KAGAWAD, BARANGAY APOLONIO SAMSON, QUEZON CITY, CHARGEABLE AGAINST THE APPROPRIATIONS FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2005 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

WHEREAS, during his incumbency he was instrumental in various beneficial projects of the barangay such as infrastructure, free medical and dental outreach and the like;


WHEREAS, in recognition of his dedicated, committed and loyal public service, it is necessary to grant financial assistance to his surviving heirs.
