RESOLUTION NO. SP-3003 (PR2005-284)

A RESOLUTION URGING THE HONORABLE CITY MAYOR, FELICIANO R. BELMONTE, JR., TO GRANT FINANCIAL ASSISTANCE TO THE VICTIMS OF THE FIRE THAT OCCURRED ON MAY 26, 2005 AT ABBY ROAD, BARANGAY BAGBAG, QUEZON CITY COMPRISING OF SEVENTEEN (17) FAMILIES HOMEOWNERS/RENTERS/SHARERS AT TWO THOUSAND PESOS (P2,000.00) EACH IN THE TOTAL AMOUNT OF THIRTY-FOUR THOUSAND PESOS (P34,000.00) TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUND OF THE CITY TREASURY.

WHEREAS, a fire occurred on May 26, 2005 at Abby Road, Barangay Bagbag, Novaliches, this City, wherein two (2) residents perished and rendering homeless seventeen (17) families homeowners/renters/sharers;

WHEREAS, Section 458 (1) (iv) of the Local Government Code of 1991 empowers the Sangguniang Panlungsod to "adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said event."

Belmonte, Jr., to grant financial assistance to the victims of the fire that occurred on May 26, 2005 at Abby Road, Barangay Bagbag, Novaliches, Quezon City comprising of seventeen (17) families homeowners/renters/sharers at Two Thousand Pesos (P2,000.00) each in the total amount of Thirty-Four Thousand Pesos (P34,000.00) to be charged against the appropriation for Grants, Subsidies and Contributions of the office of the City Mayor or from any available fund of the City Treasury.
