RESOLUTION NO. SP- 3008, S-2005  
(PR2005-282)

A RESOLUTION URGING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO GRANT FINANCIAL ASSISTANCE TO THE VICTIMS OF THE FIRE THAT OCCURRED ON MARCH 26, 2005 AT THE VICINITY BETWEEN SUSANA STREET AND ARACELLI STREET, BARANGAY GULOD, NOVALICHES, QUEZON CITY COMPRISING OF TWENTY (20) FAMILIES HOMEOWNERS/RENTERS/SHARERS AT TWO THOUSAND PESOS (P2,000.00) EACH IN THE TOTAL AMOUNT OF FORTY THOUSAND PESOS (P40,000.00) TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUND OF THE CITY TREASURY.

Introduced by Councilors RAMON P. MEDALLA, WINSTON "Winnie" T. CASTELO, AIKO MELENDEZ, VOLTAIRE GODOFREDO L. LIBAN III, ERIC Z. MEDINA and ALLAN BUTCH T. FRANCISCO.

WHEREAS, a fire occurred on May 26, 2005 at the vicinity between Susana Street and Aracelli Street, Barangay Gulod, Novaliches, this City, rendering homeless twenty (20) family-homeowners/renters/sharers;

WHEREAS, Section 458 (1) (iv) of the Local Government Code of 1991 empowers the Sangguniang Panlungsod to "adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said event."


NOW, THEREFORE,

Belmonte, Jr., to grant financial assistance to the victims of the fire that occurred on March 26, 2005 at the vicinity between Susana Street and Aracelli Street, Barangay Gulod, Novaliches, Quezon City comprising of twenty (20) families homeowners/renters/sharers at Two Thousand Pesos (P2,000.00) each in the total amount of Forty Thousand Pesos (P40,000.00) to be charged against the appropriation for Grants, Subsidies and Contributions of the office of the City Mayor or from any available fund of the City Treasury.
