A RESOLUTION URGING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR. TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF ANOTHER SB BUILDING AT PAYATAS HIGH SCHOOL SITE, THE FUND TO BE TAKEN FROM THE INFRASTRUCTURE FUND OR ANY AVAILABLE FUND OF THE CITY TREASURY.
