A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE FAMILY AND SURVIVING HEIRS OF THE LATE BARANGAY KAGAWAD VICENTE A. MARASIGAN OF BARANGAY SAN ROQUE, QUEZON CITY IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00) TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2005 ANNUAL BUDGET OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.


