A RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT REPRESENTED BY THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR. AND THE PHILIPPINE SEA GAMES ORGANIZING COMMITTEE FOUNDATION, INC., REPRESENTED BY ITS CHAIRMAN AND CHIEF EXECUTIVE OFFICER, SECRETARY ROBERTO M. PAGDANGANAN FOR FREE USE OF THE FACILITIES OF AMORANTO SPORTS COMPLEX.

WHEREAS, the City Mayor, Honorable Feliciano R. Belmonte, Jr., has entered into a Memorandum of Agreement with Philippine SEA Games Organizing Committee Foundation, Inc., represented by its Chairman and Chief Executive Officer, Secretary Roberto M. Pagdanganan, for free use of the facilities of Amoranto Sports Complex particularly the Velodrome as the official competition venue for the cycling events of the 23rd SEA Games from November 3 to December 5, 2005;

WHEREAS, the above-mentioned agreement is a pre-requisite for the conduct of Security Survey Inspection by the Philippine SEA Games Organizing Committee (PHILSOC) and Philippine Olympic Committee (POC);

WHEREAS, the Philippines was awarded the noble task of hosting the 23rd SEA Games in 2005, a duty it owes to its Southeast Asian neighbors and to its own citizens;
