A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO PETRON CORPORATION FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE SERVICE STATION LOCATED AT BATASAN HILLS TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (BATODA) MAIN TERMINAL, IBP ROAD, BARANGAY BATASAN HILLS, QUEZON CITY.

WHEREAS, petitioner Atty. Edward Ong Proprietor, Petron Corporation, a duly registered business entity under Philippine laws is applying for the issuance of a Special Use Permit (SUP) for the construction and operation of a gasoline service station located at Batasan Hills Tricycle Operators and Drivers Association (BATODA) main terminal, IBP Road, Barangay Batasan, Quezon City;

WHEREAS, gasoline service station are among the uses which require a Special Use Permit upon authorization from the Quezon City Council as provided in Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2000;

WHEREAS, the Barangay Council and the members of the Batasan Hills Tricycle Operators and Drivers Association Inc., (BATODA) have express no objection for the establishment or erection of gasoline pump of Petron Corporation;


