A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO METRO OIL SUBIC, INC. FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE SERVICE STATION LOCATED AT #76 KALAYAAN AVENUE, DILIMAN, QUEZON CITY.

Tan, a duly registered business entity under Philippine laws is applying for the issuance of a Special Use Permit (SUP) for the construction and operation of a gasoline service station at #76 Kalayaan Ave., Diliman, Quezon City;


