RESOLUTION NO. SP- **3058** , S-2005
(PR2005-337)

A RESOLUTION URGING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., THIS CITY, TO EXTEND FINANCIAL ASSISTANCE TO THE JULY 20, 2005 VICTIMS OF THE FIRE THAT BURNED THE RESIDENTIAL HOUSES OF FIVE (5) FAMILIES AT PRINSIPE TUPAZ STREET KANAN, DOÑA ROSARIO SUBDIVISION, NOVALICHES PROPER, THIS CITY, AT TWO THOUSAND PESOS (P2,000.00) PER FAMILY OWNER AND ONE THOUSAND PESOS (P1,000.00) PER FAMILY RENTER/SHARER, WHICH SHALL BE TAKEN FROM THE CALAMITY FUND OF THE CITY GOVERNMENT OR FROM ANY AVAILABLE FUNDS THEREOF.

WHEREAS, due to the occurrence of such unfortunate and devastating circumstance, they are experiencing financial difficulties and shall therefore be provided assistance in the form of cash;

WHEREAS, under the Local Government Code, local government units are empowered to adopt measures to protect the inhabitants of the City from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during the aftermath of said disasters or calamities and in their return to livelihood productive following said event.


