A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE FAMILY AND SURVIVING HERS OF THE LATE FORMER BARANGAY KAGAWAD GENEROSO S. BALADJAY OF BARANGAY MALAYA, QUEZON CITY, IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2005 ANNUAL BUDGET OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.
