A RESOLUTION URGING THE HONORABLE CITY MAYOR, FELICIANO R. BELMONTE, JR., TO GRANT FINANCIAL ASSISTANCE TO THE FAMILY OF THE LATE BARANGAY KAGAWAD PATRICIO PASCUAL OF BARANGAY BAESA, DISTRICT II, QUEZON CITY, IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) TO BE TAKEN FROM GRANTS, SUBSIDIES AND CONTRIBUTIONS OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.
