A RESOLUTION URGING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO ALLOW THE DISPOSITION OF A PARCEL OF LAND LOCATED AT CHAMPACA WEST, MALIGAYA PARK SUBDIVISION, BARANGAY PASONG PUTIK, QUEZON CITY, TO BE AWARDED TO THE ACTUAL AND QUALIFIED OCCUPANTS IN ACCORDANCE WITH THE MANNER PRESCRIBED BY LAW.

M.) covered by Transfer Certificate of Title Numbered 89083 (149905) of the Register of Deeds of Quezon City, situated at Champaca West, Maligaya Park Subdivision, Barangay Pasong Putik, Quezon City;

WHEREAS, the subject property is presently being occupied by informal settlers for the past thirty (30) years, who are members of Renaissance Neighborhood Association, Inc.;

WHEREAS, the members are now soliciting the assistance of the City government, to allow them to acquire the property.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge, the Honorable City Mayor Feliciano R. Belmonte, Jr., to allow the disposition of a parcel of land located at Champaca West, Maligaya Park Subdivision, Barangay Pasong Putik, Quezon City, to be awarded to the actual and qualified occupants in accordance with the manner prescribed by law.
