RESOLUTION NO. SP-3075, S-2005 (PR2005-444)

A RESOLUTION STRONGLY URGING THE DEVELOPMENT PLAN OF THE CW MARKETING AND DEVELOPMENT CORPORATION TO THE GOVERNMENT SERVICE INSURANCE SYSTEM (GSIS) FOR THE IMPROVEMENT AND DEVELOPMENT OF THEIR PROPERTY LOCATED AT ELLIPTICAL ROAD CORNER COMMONWEALTH AVENUE, BARANGAY OLD CAPITOL SITE, QUEZON CITY.

WHEREAS, the CW Marketing and Development Corp., proposed to improve and develop the property with an area of 29,884 sq. m. lot owned by the GSIS located at Elliptical Road corner Commonwealth Avenue, Barangay Old Capitol Site, Quezon City;

WHEREAS, the project has been proposed to construct low impact commercial building and it is envisioned to become a one-stop destination center with lifestyle retail components and support retail and services establishment;

WHEREAS, the proposed improvement of the said property will serve to promote public welfare and economic growth and development through the projected increase of employment opportunity in Quezon City;

WHEREAS, the purposes of the proposed project provided for the promotion and optimal use of the city space for future development, and providing further for the generation of more revenues and the general welfare of more constituents in Quezon City;

WHEREAS, CW Marketing and Development Corp. is a reputable business company whose track spuns from different property development in Metro Manila, all of which generated tremendous progress in the area;

WHEREAS, the proposed development project should be limited to 2 to 3-storey low impact commercial building clusters with wide open spaces;
