A RESOLUTION URGING QUEZON CITY MAYOR FELICIANO R. BELMONTE, JR., TO GRANT FINANCIAL ASSISTANCE TO THE VICTIMS OF THE FIRE THAT OCCURRED ON AUGUST 23, 2005 AT PUROK 3-A, LUZON AVENUE, BARANGAY CULIAT, DISTRICT II, CITY COMPRISING **FIFTY** (50)OUEZON OF HOMEOWNERS/RENTERS/SHARERS AT TWO THOUSAND PESOS (P2,000.00) EACH IN THE TOTAL AMOUNT OF ONE HUNDRED THOUSAND PESOS (P100,000.00) TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUND OF THE CITY TREASURY.

WHEREAS, a fire occurred on August 23, 2005 at Purok 3-A, Luzon Avenue, Barangay Culiat, District II, this City, rendering homeless fifty (50) family-homeowners/renters/sharers;

WHEREAS, Section 458 (1) (iv) of the Local Government Code of 1991 empowers the Sangguniang Panlungsod to "adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and in their return to productive livelihood following said events.";

BE IT RESOLVED BY THE CITY COUNCIL OF OUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge, Quezon City Mayor Feliciano R. Belmonte, Jr., to grant financial assistance to the victims of the fire that occurred on August 23, 2005 at Purok 3-A, Luzon Avenue, Barangay Culiat, District II, Quezon City, comprising of Fifty (50) family-homeowners/renters/sharers at Two Thousand Pesos (P2,000.00) each in the total amount of One Hundred Thousand Pesos (P100,000.00) to be charged against the appropriation for Grants, Subsidies and Contributions of the office of the City Mayor or from any available fund of the City Treasury.
