A RESOLUTION URGING QUEZON CITY MAYOR FELICIANO R. BELMONTE, JR., TO GRANT FINANCIAL ASSISTANCE TO THE VICTIMS OF THE FIRE THAT OCCURRED ON AUGUST 21, 2005 AT DON PRIMITIVO STREET AND ITS VICINITY, BARANGAY HOLY SPIRIT, QUEZON CITY, COMPRISING OF EIGHTY-SIX (86) FAMILY-HOMEOWNERS AT TWO THOUSAND PESOS (P2,000.00) EACH IN THE TOTAL AMOUNT OF ONE HUNDRED SEVENTY-TWO THOUSAND PESOS (P172,000.00) TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUND OF THE CITY TREASURY.

WHEREAS, a fire occurred on August 21, 2005 at Don Primitivo and its vicinity, Barangay Holy Spirit, this City, rendering homeless eighty-six (86) family-homeowners;

WHEREAS, Section 458 (1) (iv) of the Local Government Code of 1991 empowers the Sangguniang Panlungsod to "adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and in their return to productive livelihood following said events."





Belmonte, Jr., to grant financial assistance to the victims of the fire that occurred on August 21, 2005 at Don Primitivo Street and its vicinity, Barangay Holy Spirit, Quezon City, comprising of Eighty-Six (86) family-homeowners at Two Thousand Pesos (P2,000.00) each in the total amount of One Hundred Seventy-Two Thousand Pesos (P172,000.00) to be charged against the appropriation for Grants, Subsidies and Contributions of the Office of the City Mayor or from any available fund of the City Treasury.
