A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO DISBURSE AND RELEASE PAMASKONG HANDOG IN THE FORM OF CASH GIFT THIS CHRISTMAS SEASON FOR CONSULTANTS AND PERSONNEL OF THE QUEZON CITY GOVERNMENT COVERED BY JOB CONTRACTS FROM FUNDS ALLOCATED FOR THE PURPOSE.

WHEREAS, in view of the present economic condition of the country and the need to spread Christmas cheer to as many persons as possible, there is a need to grant Pamaskong Handog in the form of cash gift this Christmas Season to Consultants and Job Contract Personnel of the Quezon City government.




