A RESOLUTION SUPPORTING SENATE BILL 2219 (AN ACT RATIONALIZING THE CELEBRATION OF NATIONAL HOLIDAYS AMENDING FOR THE PURPOSE SECTION 26, CHAPTER 7, BOOK 1 OF EXECUTIVE ORDER NO. 292 AS AMENDED OTHERWISE KNOWN AS THE ADMINISTRATIVE CODE OF 1987) AND CALLING THE CONGRESS OF THE PHILIPPINES FOR ITS IMMEDIATE ENACTMENT.

WHEREAS, Senate Bill 2119 aims to solve the recurring problems arising from the declaration of special non-working holidays whenever the date of the holiday falls in the middle of the week.




RESOLVED, FURTHER, that a copy of this resolution be given to the Philippine Senate and to Honorable Joker Arroyo.
