OTHERWISE KNOWN AS "PHILIPPINE NATIONAL POLICE
MAGNA CARTA" AND URGING THE PHILIPPINE SENATE
AND THE HOUSE OF REPRESENTATIVES FOR ITS
IMMEDIATE ENACTMENT.

WHEREAS, Senate Bill No. 974 otherwise known as "Philippine National Police Magna Carta" addresses the fundamental problems that beset the police structure;

WHEREAS, under Senate Bill No. 974, an officer exposed to hardship and combat situation or other hazards to peacekeeping, crime prevention and investigation activities shall be compensated a combat pay allowance equivalent to at least forty percent (40%) of his monthly basic salary;

WHEREAS, additional compensation shall be provided when a policeman is required to render an actual service beyond or in excess of the ten (10) hours period;

WHEREAS, considering the critical role of PNP personnel toward the realization of peace and order, the national government should be able to guarantee the improvement of their well being;

WHEREAS, in recognition of the policeman's role in ensuring public safety and peace and order, Senate Bill No. 974 otherwise known as PNP Magna Carta should indeed be enacted.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to support, as it does hereby support, Senate Bill No. 974 otherwise known as "Philippine National Police Magna Carta" and urging the Philippine Senate and the House of Representatives for its immediate enactment;
