A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE FAMILY AND SURVIVING HEIRS OF THE LATE BARANGAY DRIVER ELIZALDE O. PADUA OF BARANGAY TAGUMPAY, QUEZON CITY, IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00) TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2006 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, financial assistance to the family and surviving heirs of the late Barangay Driver Elizalde O. Padua of Barangay Tagumpay, Quezon City, in the amount of Forty Thousand Pesos (P40,000.00) to be charged against the appropriation for Grants, Subsidies and Contributions under the 2006 Annual Budget of the Office of the City Mayor or from any available funds of the City Treasury.
