A RESOLUTION PROVIDING FINANCIAL ASSISTANCE TO THE SURVIVING HEIRS OF THE LATE HONORABLE ROMEO H. VILLANUEVA, BARANGAY CAPTAIN OF BARANGAY ALICIA, DISTRICT I, THIS CITY, IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00) IN RECOGNITION OF HIS DEDICATED AND EXEMPLARY SERVICE TO HIS BARANGAY AND TO THE CITY, TO BE CHARGED FROM GRANTS, SUBSIDIES AND CONTRIBUTIONS OF THE 2007 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS IN THE CITY TREASURY.

WHEREAS, the Honorable Romeo H. Villanueva, Barangay Captain of Barangay Alicia, District I, this City has joined his creator on December 3, 2006 at the age of 60;

WHEREAS, he dedicated his life serving his constituents as Barangay Kagawad from May 1982 to 1989 and Barangay Captain from May 1994 until his untimely demise;

WHEREAS, his legacy will always be remembered by his constituents, as he contributed much to the development and progress of his barangay and his people;

WHEREAS, as a token of gratitude to the loyal and humble services he had shown to his constituents and to City as a whole, it is but appropriate for the City government to render some financial assistance to lighten the financial burden of his family as a consequence of his untimely demise.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to provide, as it does hereby provide, financial assistance to the surviving heirs of the late Honorable Romeo H. Villanueva, Barangay Captain of Barangay Alicia, District I, this City, in the amount of Forty Thousand Pesos (P40,000.00) in recognition of his dedicated and exemplary service to his barangay and to the City, to be charged from grants, subsidies and contributions of the 2007 Annual Budget of the Office of the City Mayor or from any available funds in the City Treasury.
