RESOLUTION URGING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR. TO GRANT FINANCIAL ASSISTANCE TO THE FAMILY OF THE LATE FORMER BARANGAY KAGAWAD ANTONIO S. GALGUERRA OF BARANGAY TALIPAPA, DISTRICT II, QUEZON CITY, IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00), TO BE TAKEN FROM GRANTS, SUBSIDIES, AND CONTRIBUTIONS OF THE 2007 ANNUAL BUDGET OR ANY AVAILABLE FUNDS OF THE CITY TREASURY.


