A RESOLUTION PROVIDING FINANCIAL INCENTIVE/HONORARIA TO ALL BARANGAY SECURITY DEVELOPMENT OFFICERS (BSDOS) IN ALL BARANGAYS OF DISTRICT I QUEZON CITY, IN THE AMOUNT OF ONE THOUSAND PESOS EACH (P1,000.00) EVERY MONTH, TO BE CHARGED FROM GRANTS, SUBSIDIES AND CONTRIBUTIONS OF THE 2007 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS IN THE CITY TREASURY.

WHEREAS, the City government recognizes the invaluable contributions of Barangay Security Development Officers (BSDOs) who serve their communities through their dedication to peace-keeping measure;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to provide, as it does hereby provide, financial incentive/honoraria to all Barangay Security Development Officers (BSDOs) in all Barangays of District I, Quezon City, in the amount of One Thousand Pesos each (P1,000.00) every month to be charged from grants subsidies and contributions of the 2007 Annual Budget of the Office of the City Mayor or from any available funds in the City Treasury.

RESOLVED, FURTHER, that a copy of this Resolution be given to the Board of Directors of the BSDO Federation of District I of Quezon City. c
