A RESOLUTION URGING THE HONORABLE FELICIANO R. BELMONTE, JR., TO GRANT FINANCIAL ASSISTANCE TO THE FAMILY OF THE LATE FORMER BARANGAY KAGAWAD CIPRIANO TIMBAS OF BARANGAY BAGONG SILANGAN, DISTRICT II, QUEZON CITY, IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00) TO BE TAKEN FROM GRANTS, SUBSIDIES, AND CONTRIBUTIONS OR FROM ANY AVAILABLE FUND OF THE CITY TREASURY.
