A RESOLUTION AMENDING RESOLUTION NO. SP-3281, S-2006 BY INCORPORATING THEREON THE NAME OF ANTONIO HERMANO NG LIO AS THE REGISTERED OWNER OF CERTAIN PARCEL OF LAND DESCRIBED AS LOT 522-A, PSD-00-038307, CONTAINING AN AREA OF FIVE HUNDRED TWENTY THREE SQUARE METERS (523.00 SQ. M.) LOCATED AT BARANGAY TALIPAPA, NOVALICHES, QUEZON CITY, IN PLACE OF THE NAME ARMANDO HERMANO NG LIO.

WHEREAS, on March 20, 2006 the City Council has approved Resolution No. SP-3281, S-2006, entitled "A resolution authorizing the City Mayor, Honorable Feliciano R. Belmonte, Jr., to enter into a contract for the purchase of that parcel of land, described as Lot 522-A PSD-00-038307, containing an area of Five Hundred Twenty Three Square Meters (523.00 Sq. M.) located at Barangay Talipapa, Novaliches, Quezon City, registered in the name of Armando Hermano Ng Lio, et.al., under TCT No. N-274501 of the Registry of Deeds of Quezon City;



WHEREAS, in its 1st Indorsement dated 4 December 2006, copy thereof is attached, the Office of the City Attorney, through Atty. Christian B. Valencia, recommended the adoption of a new Resolution to incorporate the correct name of the registered property owner.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to amend, as it does hereby amend, Resolution No. SP-3281, S-2006 by incorporating thereon the name of Antonio Hermano Ng Lio as the registered owner of certain parcel of land described as Lot 522-A, PSD-00-038307, containing an area of Five Hundred Twenty Three Square Meters (523.00 Sq. M.) located at Barangay Talipapa, Novaliches, Quezon City, in place of the name Armando Hermano Ng Lio.
