A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO PETRON CORPORATION FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE SERVICE STATION LOCATED ALONG KATIPUNAN AVENUE CORNER MANGYAN STREET, BARANGAY PANSOL, QUEZON CITY.

WHEREAS, petitioner Petron Corporation, a duly registered, business entity under Philippine laws, represented by its Manager Mr. Renato G. Abundo is applying for the issuance of a Special Use Permit (SUP) for the construction and operation of a gasoline service station located along Katipunan Avenue corner Mangyan Street, Barangay Pansol, Quezon City;

WHEREAS, gasoline service stations are among the uses which require a Special Use Permit upon authorization from the Quezon City Council as provided in Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2000;




