RESOLUTION GRANTING BURIAL ASSISTANCE TO THE FAMILY AND SURVIVING HEIRS OF THE LATE BARANGAY TANOD DANILO A. SUPERABLE, SR., OF BARANGAY SIKATUNA VILLAGE, QUEZON CITY, IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00), TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES, AND CONTRIBUTIONS UNDER THE 2007 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS IN THE CITY TREASURY.

WHEREAS, the late Danilo A. Superable, Sr., started as Barangay Security and Development Officer since 2002;


WHEREAS, during his term, the late Superable, Sr., had faithfully and selflessly served his constituents;
