A RESOLUTION URGING QUEZON CITY MAYOR FELICIANO R. BELMONTE, JR. TO GRANT FINANCIAL ASSISTANCE TO THE VICTIMS OF THE FIRE THAT OCCURRED ON DECEMBER 20, 2006 AT PINAGKAIKAIHAN STREET, BARANGAY COMMONWEALTH, QUEZON CITY, COMPRISING OF SEVEN (7) FAMILY-HOMEBOWNERS AT TWO THOUSAND PESOS (P2,000.00) EACH, IN THE TOTAL AMOUNT OF FOURTEEN THOUSAND PESOS (P14,000.00) TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUND OF THE CITY TREASURY.

WHEREAS, a fire occurred on December 20, 2006 at Pinagkaisahan Street, Barangay Commonwealth, this City, wherein seven (7) families were rendered homeless;

WHEREAS, Section 458 (1) (iv) of the Local Government Code of 1991 empowers the Sangguniang Panlungsod to "adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events."


