RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO EXTEND FINANCIAL ASSISTANCE TO SIXTEEN (16) FAMILIES AFFECTED BY THE FIRE THAT RAZED A RESIDENTIAL AREA ON DECEMBER 22, 2006 AT NAMALU STREET, AREA 5, LUZON AVENUE, BARANGAY MATANDANG BALARA, DISTRICT III, THIS CITY, AT TWO THOUSAND PESOS (P2,000.00) PER FAMILY OWNER AND ONE THOUSAND PESOS (P1,000.00) PER FAMILY RENTER/SHARER WHICH SHALL BE TAKEN FROM THE CALAMITY OR EMERGENCY FUND OF THE CITY GOVERNMENT OR FROM ANY OTHER AVAILABLE FUNDS IN THE CITY TREASURY.

WHEREAS, local government units are empowered under Section 458 par. A (iv) of RA 7160 "to adopt measures to protect the inhabitants of the City from the harmful effects of the man-made or natural disasters and calamities, and to provide relief services and assistance for victim during and in the aftermath of said disasters or calamities, and in their return to productive livelihood following said events";

WHEREAS, a fire razed houses at the residential area of Namalu Street, Area 5, Luzon Avenue, Barangay Matandang Balara, District III, this City, on December 22, 2006.



BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as its does hereby authorize, the Honorable Feliciano R. Belmonte, Jr., City Mayor, to extend financial assistance to sixteen (16) families affected by the fire that razed a residential area on December 22, 2006 at Namalu Street, Area 5, Luzon Avenue, Barangay Matandang Balara, District III, this City, at Two Thousand Pesos (P2,000.00) per family owner and One Thousand Pesos (P1,000.00) per family renter/sharer, which shall be taken from the Calamity or Emergency Funds of the City Government or from any available funds in the City Treasury.

RESOLVED, FURTHER, that the Social Services Development Department, in coordination with the barangay officials of Barangay Matandang Balara, shall authenticate the beneficiaries of this financial assistance.
